**Waiver and Release**

1. I/my child desires to participate voluntarily in a class, construction, preparation, and/or other activities sponsored by and/or coordinated at The Urban Farm™ site, its surrounding grounds or designated operating sites.
2. I understand, accept and assume the risks associated with my/ my child's participation in any and all activities. Our programs are designed to introduce you to the wonderful world of horses, livestock and farming. Though we are committed to provide a safe environment for both humans and animals, these activities can be dangerous and accidents can happen. **Under Colorado Law, an equine professional is not liable for injury to or death of a participant in equine activities resulting from inherent risks of equine activities pursuant to Section 13-21-119, Colorado Revised Statutes. Under Colorado law, activity instructor, equipment provider or facility personnel shall not be civilly liable for an injury to or the death of a participant resulting from the inherent risks of agricultural recreation activities pursuant to Section 13-21-121 of the Colorado Revised Statutes.)**
3. I assume full responsibility for any injuries which may occur to me/my child, as well as my family members and others for whom I am legally responsible and do hereby fully and forever discharge and release the farm landowner, Embracing Horses™, their employees, executive directors, board members, officers, agents, authorized volunteer helpers, representatives, consultants, insurers and sureties, and their successors and assigns (collectively, the "Released Parties"), from any "Claims".  
  
"Claims" as used in this document means any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of my presence or the presence of my family members, guests and others for whom I am legally responsible on the farm, activities at the farm, the use or intended use of the farm, and/or participation in activities connected with Embracing Horses™ including, without limitation, any of the foregoing resulting from or arising out of the negligence of a Released Party. Further, I hereby waive any and all Claims against a Released Party.
4. I hereby give consent to use (my) (my child's) name, picture, portrait, likeness, writings or biographical information, and audiotape and/or videotape recordings and sound or silent motion pictures of (me) (my child) in any media for editorial, educational, promotional and advertising purposes, for the solicitation of contributions, and for any other purpose in furtherance of the corporate purposes and objectives of Embracing Horses™ and the land owner.
5. I expressly acknowledge that participation in The Urban Farm™ is for my/my child's purposes and convenience and not for the purpose and convenience of any one or more of the Released Parties.
